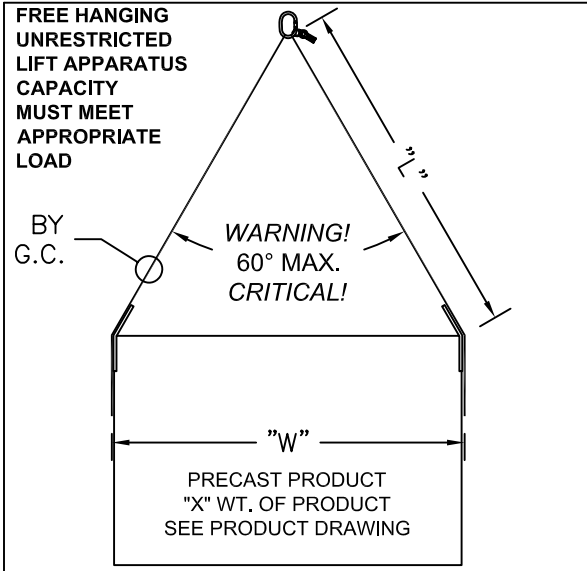

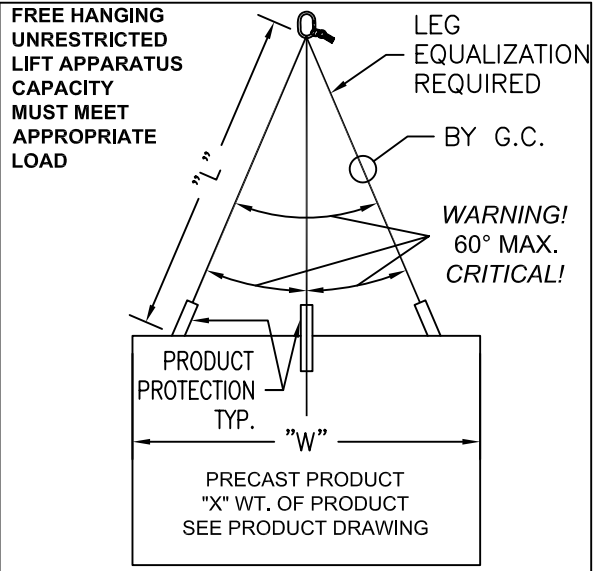

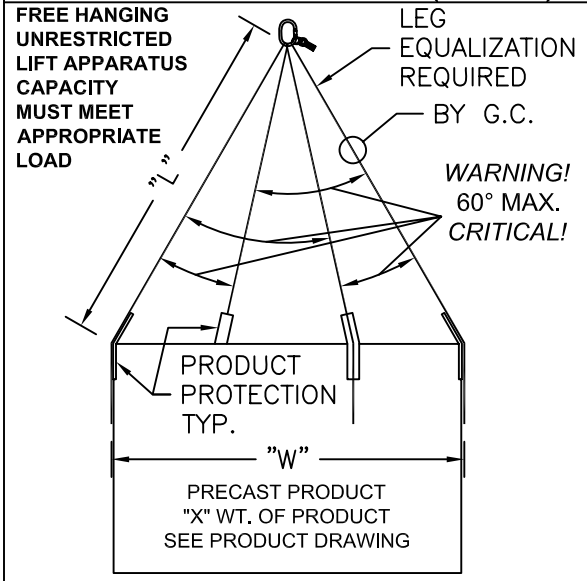
**2-WAY LIFT**

NOTE: "L" MUST BE EQUAL TO OR GREATER THAN "W" MAX. (ie.  $L \geq W$ )



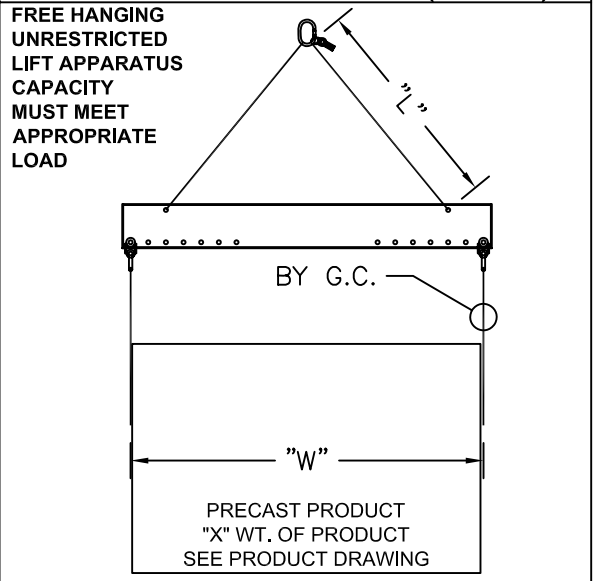
**3-WAY LIFT**

SUBJECT: SUSPENDED LOAD POLICY - DEL. & FIELD

No individual shall walk stand or pass under or near a suspended load unless the load is lowered over suitable substantial blocking or supports. Should the lifting device fail, the load must be able to fall safely and securely on such blocking or supports.

This formal policy and warning is to inform all Kistner Personnel as well as Site Contractors, Site Inspection Agency's or any and all other Personnel on site that it is not, never has been, nor will be the Kistner company's policy to endorse, accept, tolerate, or in any way recognize as acceptable practice of passing near or under a suspended load. If anyone observes this practice in any phase of our operations, it must be stopped immediately by reinforcing this policy. The Kistner Concrete Products Co. is committed to having a safe working environment and not complying with this policy is considered a very serious violation.

All Kistner Employees as well as Project Site personnel should be advised of this policy and be alert to potential suspended load failure condition. No one should knowingly take a chance going near or under a suspended load.

Education is the key. All employees and site personnel, when questioned on this topic must respond with a clear understanding of this policy.

All employees shall be kept clear of loads about to be lifted and of suspended loads. OSHA RULE #29 CFR 1910.184(x)(9)
